Notice Regarding Partial Amendments to the Articles of Incorporation

Oji Holdings Corporation (hereinafter "Oji Holdings") hereby announces that a meeting of the Board of Directors held today passed a resolution as follows, to propose "Partial Amendments to the Articles of Incorporation" at the 95th Ordinary General Meeting of Shareholders to be held on June 27, 2019.

1. Reason for the Amendments to the Articles of Incorporation

The Company will add business purposes to Article 2 (Purpose) of the current Articles of Incorporation in order to clarify its business activities. The additions include creation of new products and businesses through the pursuit of innovation, etc. in which the Company united with its Group companies, and to arrange the business purpose statement.

2. Details of the Amendments to the Articles of Incorporation The details of the amendments are defined in Attachment.

Current Articles of Incorporation

Article 2. (Purpose)

- 1. The purpose of the Company shall be to own the shares or equity of a company or companies engaged in the following businesses, as well as those of a foreign company or foreign companies engaged in equivalent businesses, thereby having control over and managing such companies.
