

Groundbreaking Recycling: First in Japan to turn aseptic carton packages into corrugated containers, Debuts at Expo 2025 Osaka ~ Collaboration by Oji Holdings, Nihon Tetra Pak, and Gold Pack ~ –

Oji Holdings Corporation (President: Hiroyuki Isono, Head Office: Chuo-ku, Tokyo) announce its collaboration with Nihon Tetra Pak K.K. (President: Niels Hougaard, Head Office: Minato-ku, Tokyo; hereinafter "Tetra Pak") and Gold Pack Co., Ltd. (President: Toshio Uji, Head Office: Shinagawa-ku, Tokyo; hereinafter "Gold Pack") to commercialize Japan's first recycling technology that remanufacture aseptic carton packages, which were primarily incinerated, into corrugated containers. The recycled corrugated containers are used as packaging material for mineral water distributed at the Nordic Pavilion of the Expo 2025.

■ Japan's First Realization of Recycling aseptic carton packages into Corrugated Containers Historically, most aseptic carton packages were primarily subjected to thermal recycling, such as incineration, with material recycling (reuse for paper products) limited to just 3.6% (**1).

Oji Holdings and Nihon Tetra Pak have established Japan's first recycling system to remanufacture aseptic carton packages into corrugated containers, and now aim to promote widespread adoption in industries such as the food industry and beyond.

In collaboration with Gold Pack, which manufactures mineral water in "Nordic Circle" original-design packages, the use of recycled corrugated containers marks the beginning of further adoption, with expectations for accelerated use of recycled containers in the future.

By creating new recycled products, we expect to expand their application and further promote collection and recycling. We are very pleased to be able to deliver bottled water in paper containers using recycled corrugated containers, and to offer this at the iconic EXPO 2025. Through a single bottle of water, visitors will experience resource circulation and environmental value. Moving forward, we will continue to promote the collection and recycling of paper containers and increase the opportunities for using recycled products such as containerboard, contributing to the realization of a circular society."

Gold Pack Co., Ltd. - Jungo Momose, General Manager, Corporate Planning Department

"Gold Pack has set as its environmental policy the goal of achieving harmony between corporate activities and nature/environment, and we are making various efforts to contribute to the realization of a circular society. These efforts have been recognized, and we have been certified as a 'Water Circulation ACTIVE Company' by the Cabinet Secretariat's Water Cycle Policy Headquarters for actively implementing water-related initiatives in the 6th year of the Reiwa era. As a new initiative, we have participated in efforts to use recycled corrugated containers made from aseptic carton packages.
