

# Oji Holdings recognized with an 'A' score in CDP Forest (Timber) for its sustainable forest management

*Tokyo, December 13:* Oji Holdings Corporation (President: Hiroyuki Isono) has been recognized for leadership in corporate transparency and performance on forests by global environmental non-profit CDP\*1, securing a place on its annual 'A List' \*2.



As a Forests A List company, we are leaders in corporate transparency and action on deforestation.

- \*1 CDP's annual environmental disclosure and scoring process is widely recognized as the gold standard of corporate environmental transparency. In 2022, over 680 investors with over US\$130 trillion in assets and 280 major purchasers with US\$6.4 trillion in procurement spend requested companies to disclose data on environmental impacts, risks and opportunities through CDP's platform. A record-breaking 18,700 companies responded.
- \*2 More than 330 companies worldwide have been recognized as global leaders in transparency and performance on environmental issues with CDP Climate Change, Forests, and Water Security A Lists. Ninety-one of the A List companies are from Japan: 74 for Climate Change, 4 for Forest, and 35 for Water Security, all of which are the most in the world.
